Dear Parent/Carer,

You may have seen in the media the Department for Education's (DfE) announcement that schools are permitted to make Friday 18<sup>th</sup> December a 'non-teaching' day. I am writing to reassure you that we will <u>not</u> be amending our term dates or our scheduled INSET days as we recognise the significant disruption this causes our families. This means our last day of term for pupils will remain Friday 18<sup>th</sup> December.

Below is an extract from the DfE guidance regarding contact tracing after school ends and a table showing the arrangements for our school:

- Where a pupil or staff member tests positive for coronavirus (COVID-19), having developed symptoms more than 48 hours since being in school, the school should not be contacted. Parents and carers should follow contact tracing instructions provided by NHS Test and Trace.
- For the first 6 days after teaching ends, if a pupil or staff member tests positive for coronavirus (COVID-19), having developed symptoms within 48 hours of being in school, the school is asked to assist in identifying close contacts and advising self-isolation, as the individual may have been infectious whilst in school.

	We have set up a designated number for parent/carers to contact in the event of a confirmed case between the close of school on Friday 18 <sup>th</sup> December and Thursday 24 <sup>th</sup> December. The numbers at the end of this letter are to be used exclusively for contact tracing purposes and no other communications.

- when waiting for a test result, remember it is advisable to take necessary steps whilst awaiting confirmation.
- ensure you continue to adhere to social distancing protocol.
